

## CONTEST

Official Contest Rules of Pan-Insula Disposal Ltd.'s "Pacific Getaway" Contest

### Duration

1.1 The "Pacific Getaway" Contest ("the Contest") is organized by Pan-Insula Disposal Ltd. ("Pan- Insula"). The Contest begins **January 02 2017**, and continues annually until further notice at 4:00 PM, when a winner will be drawn.

### Eligibility

2.1 The Contest is open to all customers of Pan-Insula's garbage removal service. In order to win, a customer must be at least 19 years of age, and must be a resident of Canada. No persons who are employees of the Pan-Insula, nor industry partners, and their affiliated companies, advertising and promotion associated with this competition, suppliers, employee or subcontractor of a provincial liquor and, respectively, any person with whom an employee, agent or representative is domiciled or any member of his "immediate family". For the purposes of these Contest Rules, "immediate family" includes mother, father, brother (s), sister (s), child (ren), husband, wife or partner (s) of fact such employee, agent or representative.

### How to Participate

3.1 NO PURCHASE NECESSARY. All regular customers will be entered automatically. In order to win, a customer must have been a regular monthly subscriber by the **July 1, annually**, and must continue to be a regular monthly **subscriber who's account is in** good standing order on the date the winner is selected. Pan-Insula reserves the right to disqualify any person who violates or attempts to violate the rules of this Contest .

### Prize

4.1 The winner will receive one (1) prize with an approximate value of **\$3200.00** which is as follows:

- a) Open destination to anywhere winners wishes to travel

### Draw

- 5.1 The draw will take place on **September 1, (if falls on a Saturday or Sunday draw will be the next business day)** annually at 12:00 PM (Pacific), at the Pan-Insula and Brentwood Metal yard facility located at 7481 West Saanich Road, Saanichton, BC. One (1) entry will be randomly drawn from all eligible entries received. Any selected

entrant will be notified by telephone and email. Subscribers do **NOT** need to be physically at the site on the draw date in order to qualify.

- 5.2 In the event that Pan-Insula cannot managed to reach the winner by phone or email within two (2) working days of the draw, the entrant will be disqualified and an alternate winner will be selected.
